QUICK-START INSTRUCTIONS

1. Fill in all applicable fields and email it to: anpcorders@gmail.com
2. **Approve estimate & pay invoice.** After review, we will send a custom estimate. Once approved, an invoice will be emailed. Work begins after payment is received.
3. **Receive your IRS EIN letter (CP575)** The IRS will mail your EIN letter to the address on the application. Timing: approximately 4–8 weeks (allow up to 10 weeks).
4. **Send the EIN letter immediately.** As soon as you receive the CP 575 letter: SCAN IT AND EMAIL IT TO US IMMEDIATELY. (We cannot complete your trust without it.)
5. **Trust completion**
Once we receive your EIN letter, we finalize your custom trust package.

DEFINITIONS OF TRUST POSITIONS

TRUSTEE: The person appointed, or required by law, to execute a trust; one in whom an estate, interest, or power is vested, under an express or implied agreement to administer or exercise it. (Usually use a variation of your Upper/Lowercase “Name” Here. i.e: John Ray Doe or John R. Doe---this is not your Living Man.)

CREATOR: The originator of the TRUST, appoints the TRUSTEE, SETTLOR & SUCCESSOR **TRUSTEES.** (This will be either Another 98 Trust OR a Variation of your Upper Lowercase Name again i.e. John Doe or INFINITY TRUST etc)

SETTLOR: The grantor or donor in a deed of settlement, oversees the trust, even though in form the trust is created by another. (THIS IS SAME AS TRUSTEE)

SUCCESSOR TRUSTEE: A person that will assume TRUSTEE position when main TRUSTEE dies or resigns.

VERY IMPORTANT NOTE!!! You CANNOT use a trust mailing address that is tied to your name in any way through banking, Post Office, IRS, Social Security, lawsuit, old driver’s License etc. You can use a friend or family members address OR get a new PO Box WITHOUT A SSN using your ID, IDP etc.
